

## **“#EXCUSES4FIJI” CONTEST TERMS & CONDITIONS**

The **#Excuses4Fiji** (the “Contest”) is organised and conducted by Changi Airport Group (Singapore) Pte Ltd (“CAG”). This is a Contest whereby participants submit an excuse for going to Fiji.

### **Contest Duration**

1. The Contest shall commence on 4 April 2018 and end on 19 April 2018 (2359hrs).

### **Contest Mechanics**

2. The Contest calls for each participant to submit an excuse on why they deserve to go on holiday and for a chance to win a 5D4N holiday for two to Fiji in 2019 (“Prize”).
3. The excuse can be self-created or generated by the #Excuses4Fiji Generator on <http://excuses4fiji.changiairport.com>.
4. Submissions must be made on <http://excuses4fiji.changiairport.com>. Only complete entries will qualify for consideration.

### **Contest Eligibility**

5. The Contest is open to residents of Singapore, of at least 18 years of age (as at 4 April 2018).
6. Only one (1) entry is allowed per person.
7. The participant should use real personal details for registration. CAG reserves the right, in its sole and absolute discretion; to disqualify any person from participating in the Contest should any doubts arise as to the authenticity of the relevant personal data supplied.

### **Prizes**

8. One winner (“Winner”) will be picked based on its originality and creativity of the excuse.
9. The grand prize is a 5D4N holiday for two to Fiji in 2019. The package consists of:
  - a) Two (2) Fiji Airways Economy Class return tickets to Fiji on Fiji Airways (direct flights only) (Singapore and Fiji airport taxes are to be self-funded), redeemable for travel in 2019 (as defined as a consecutive 5-day period), subject to prevailing or available flight schedules.
  - b) Four (4) nights free hotel accommodation for two (2) persons on a twin-sharing basis.

10. The Winner will be announced by 31 May 2018.
11. The Winner will be notified via phone and/or the email address that they provide on the registration form.
12. The Winner may be required to bear taxes and surcharges as may be applicable. The prize is subject to its respective terms and conditions set by the airline.
13. The Winner will receive a prize letter from CAG as proof of the prize and thereafter the winners shall contact the airline to redeem their air tickets and accommodation, subject to eligible travel period.
14. CAG reserves the right to request the Winner to provide proof of identity and age, proof of residency and other relevant proof(s) as required by CAG, in order to claim the prizes. In the event that the Winner is unable to provide proof of eligibility which is satisfactory to CAG, he or she shall be deemed to have forfeited his or her prize in whole and no substitute shall be offered.
15. CAG reserves the right to amend or substitute the prizes at any time without notification.
16. All prizes are non-exchangeable, non-refundable and non-transferable and may be subject to availability.
17. Any prizes not claimed within one month upon contact will be forfeited. CAG reserves the right to disqualify non-contactable winners.

If, for some reason, any Winner cannot be contacted within a period of time as determined by CAG or if any Winner does not acknowledge receipt of the prize within a period of time as determined by CAG, CAG **reserves** the right to award the prize to a replacement winner, forfeit the prize and/or donate the prize to charity.

Directors, employees (and/or immediate family members of such directors or employees) of CAG and its subsidiaries, the Civil Aviation Authority of Singapore, CAG's appointed software designer/manager (including KRDS Digital Pte Ltd), agencies, event management companies, retail partners/shop tenants at Changi Airport, and any other persons involved in organising, promoting and/or conducting the lucky draw, are not eligible to participate in the Contest. For the purpose of this Clause, **'immediate family members'** shall include spouses, children, parents, parents-in-law and siblings.

23. Registered participants are providing information to CAG. All received information will not be disclosed to any other organisations unaffiliated to CAG. All information provided may be used for research and statistics and will not be sold or given to any third party.
24. CAG may reject any entry on any basis including, but not limited to, incomplete entry, fraud and/or failure to comply with the Terms and Conditions stated herein.

### **Liabilities**

25. CAG's decision is final and no correspondence will be entertained. CAG reserves the right to amend or change the Terms and Conditions herein at any time without prior notice. Participation in this Contest shall constitute acceptance of the Terms and Conditions herein and any subsequent amendment(s) thereof. Failure to comply with these Terms and Conditions shall result in forfeiture of participation in this Contest.

CAG has the right, in its sole and absolute discretion, to determine all matters pertaining to the Contest (including but not limited to the award of prizes), to amend these Terms and Conditions, and to terminate this Contest at any time without prior notice. Registered users shall not be entitled to any damages or compensation whatsoever or howsoever arising as a result of such determination, amendment or termination.

CAG will not be liable for any claims, costs, injuries, losses or damages of any kind whatsoever arising out of or in connection with the Contest (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in false light).
